What is a 508(c)(1)(a) FBO?

A **508(c)(1)(a) Faith-Based Organization** is a legally recognized **tax-exempt entity** under federal law, specifically within the **Internal Revenue Code (IRC) Section 508(c)(1)(a)**. Unlike **501(c)(3) nonprofit corporations**, which are **subject to IRS regulation and oversight**, a **508(c)(1)(a) FBO is inherently tax-exempt and does not require IRS approval**. This means that:

- The Lodge is **automatically exempt from federal income tax**
- We **do not file annual 990 tax returns**
- Our affairs remain **private, unregulated, and beyond IRS interference**
- **Donations to the Lodge are tax-deductible** for contributors
